The FAA does not have the legal authority to force pilots to comply with the county's voluntary noise abatement program. The county is responsible for monitoring and investigating pilots who do not comply with the voluntary noise program. The FAA does not implement curfews.

SAN DIEGO COUNTY REGIONAL AIRPORT AUTHORITY

THE LEGISLATION THAT CREATED THE AIRPORT AUTHORITY MANDATES THREE MAIN RESPONSIBILITIES:

- **Operate San Diego International Airport**
- **Plan for the future air transportation needs of the region**
- **Serve as the region's Airport Land Use Commission – and ensure the adoption of land use plans that protect public health and safety surrounding all 16 of the county's airports.**

The Airport Authority is governed by an appointed board of nine members who represent all areas of San Diego County and three ex-officio members.

THE SAN DIEGO COUNTY GRAND JURY

THE PENAL CODE REQUIRES THE GRAND JURY TO:

- 1. Inquire into the condition and management of the public prisons within the county;**
- 2. Investigate and report on the operations, accounts and records of county officers, departments or functions;**
- 3. Inquire into the willful or corrupt misconduct in office of public officers; and**
- 4. Submit a final report of its findings and recommendations no later than the end of its term to the Presiding Judge of the Superior Court. Agencies to which these recommendations are directed are required to respond.**
